



## **PROTOCOL**

Believe it or not - it is already that time of our Lion's year to consider



#### The All Important Club Nominating Committee

In the midst of all our service work and fund raising projects throughout the year, the appointing of the Nominating Committee is often forgotten, overlooked, or left to the last minute. Yet, it may very well be one of the most important committees in any Lions club.

NOW is the time of the year when Clubs must activate this committee as any Lions club's future success will depend, in large measure, upon having qualified, truly dedicated leaders! All clubs must have leaders who are willing to make a commitment of their time and energy. Only then, are Lions Clubs able to be responsive to the ever increasing service needs of their communities.

A club President should NOT "rush through the process" but think deeply about the composition of the Nominating Committee. Only knowledgeable Lions should be appointed to the Nominating Committee. Incidentally, Robert's Rules of Order clearly states that the one committee to which the Club President/Chairperson should not be a member of is the Nominating Committee! Over the experience of several years, many clubs in our District have benefitted from the excellent practice of appointing their three most recent "King Lions" to be members of the Nominating Committee as they, perhaps better than most other members, have observed in their respective terms of office, who "can best be relied upon to get the job done".

Have you ever noticed that those clubs, who are continually able to answer the call "TO SERVE", are the <u>very same ones</u> who grow, not only in Membership, but in community stature? People will always volunteer to join any organization with a good reputation. Those Lions Clubs I know ,who have built a good reputation for service in their community, have done many things well, but <u>two</u> specific qualities come to mind.

First, they paid great attention to developing their member's leadership skills. They did **not** believe that all they had to do in selecting their officers for the next year, was "to just bump their present officers up one line". Secondly, they recognized that the members of the Club Nominating Committee have an arduous responsibility, that of making recommendations to their clubs as to who may best serve their clubs as Officers for the coming year.

With this in mind, the Nominating Committee members should carefully read and refer to the actual duties of each officer on their Board of Directors, found in both our Lions Club Constitution and By-Laws, Article V11 ("OFFICERS"), and the "Club President's Manual". This part of the process should <u>not</u> be glossed over, or taken lightly as each position has different expectations. Only then, should the Nominating Committee endeavor to "match up" the skill sets, experience and even "individual personalities" to each officer position. <u>ALL</u> members of the club should be given consideration for Board positions - this is one place where we do not run a "popularity contest"! Likewise, an individual member's "particular interests" should be given some attention. In short, any Nominating Committee has to strive to put "round pegs into round holes".

For a club to remain healthy, there should always be a <u>reasonable balance between</u> nominating "older, or long time members" and adding "newer, or more recently inducted members" of a Lions club. <u>Nothing will kill a club more quickly than the "old quard continually holding power" or "delegating the rookies" to the sidelines</u>. Lions International, in their many years of surveys, have documented proof that this is one of the major reasons for newer members "dropping out", resulting in declining membership in both small and large clubs.





There are two other requirements for Nominating Committee members to remember each is important. One, that before being nominated, a member must be "in good standing". This means that their dues must be paid up in full . There may be an occasional exception, but generally speaking, members who are lax in paying their dues on time, are not as likely to be as attentive to performing their Board of Directors duties in the future as they should be. Two, before presenting their report to their Lions Club, the committee must contact every member being considered for office to receive that member's agreement that they are willing to serve in the capacity to which they have been nominated. Nothing is more embarrassing to the committee's work than to have a Lion stand up at a meeting, particularly if there are visitors, and state "I wasn't called about this", or "No thanks, I do not wish to serve the club in this office".

#### NUMBER OF MEETINGS required to complete the Nomination and Election Process?

I quote Lions International's statement re "General Principles Regarding Elections"---"all elections should be quided by the provisions contained in the respective club, district and International Constitution, or by any rules of procedure adopted by the respective club or district for elections or by local stature or common law". Otherwise, all questions of order of procedure should be determined in accordance with Robert's Rules of Order, Newly revised". A process that works for a club with a large membership may not be suitable for a club struggling to survive with a small membership. An example., even in our district, we have many clubs with more than 50 members and just as many with 15, or less.

Did you know that at the 2007 Lions International Convention, Article 1V, Sections 2 and 3, were revised to read that "Nominations made be made from the floor of the Nomination meeting". I understand that this was done to accommodate the variety of wishes that different clubs may entertain as best for their individual circumstances. This can be a distinct change from the past as now clubs may take just TWO meetings to complete the process., the initial meeting to receive the Committee's report AND present nominations from the floor, The club's next scheduled regular meeting, (a second meeting), now becomes your "Election Night" meeting. The second option, likely more familiar to most District "N" Lions, is to continue the tradition of the past - which takes THREE meetings to complete. This option is still acceptable, still valid., it all depends on what your club wants to do. Obviously, a club must decide before hand which way they want to go.

At meeting, "No.1" the committee presents a completed report to a regular meeting of the club., no other action is taken at this meeting. This allows every member reasonable time to consider nominating other Lions for any office. It also allows any member, who may wish to run for office and was not nominated, the opportunity to solicit support and have his/ her name offered at the next regularly scheduled meeting. By the way, according to Robert's Rules of Order, no member of the Nominating Committee shall be "penalized" because they were a member of the Nominating committee - that is to say each member retains the right to be nominated for office. Also, an individual member can be nominated for more than one position. However, the Order of Nomination has to be observed., if elected to a higher office, then a member must "drop off' the ballot when the turn comes for electing a" lower" position.

At meeting, "No.2" the club's next scheduled regular meeting, Nominations from the floor are received. No other action is taken at this meeting. The Order of Nomination follows: President., 1<sup>st</sup>., 2<sup>nd</sup>., 3<sup>rd</sup>. Vice Presidents., Secretary. Treasurer.,

2 -Two Year Directors., Lion Tamer., Tail-twister., Membership Chairperson There is no election for Immediate Past President ., the two "One" Year directors are serving out their final (i.e. second) year of their election from the *previous* Lionistic year.

At meeting, "No.3 an Election, if necessary is held by secret ballot, to fill all the offices on the Board where more than one nomination has previously been received. A committee should be appointed by the club to count the ballots, but often this is an extra duty of your Nominating Committee.

# MINUTES OF THE INTERNATIONAL ASSOCIATION OF LIONS CLUBS DISTRICT N-1 THIRD CABINET MEETING SIMONDS LIONS CLUB 3 FEBRUARY, 2008.

Registration was taken prior to the Cabinet Meeting by CST George Mitton. 24 clubs and a total of 92 members registered. Including 7 Zone Chairs and 27 Committee Chairs.

District Governor Luke Stennick called the meeting to order at 11:10 a.m.

Lion Betty Hoban led in the singing of "The Star Spangled Banner" and "O Canada.."

DG Luke led in a moment of silence for world peace and deceased lions and the Lions Invocation.

DG Luke then called for approval of the agenda. It was moved by PCC Rheal Cormier and seconded by Lion Norah Davidson-Wright, that the agenda be approved, motion carried.

DG Luke welcomed all in attendance and delivered his opening remarks.

DG Luke then introduced the head table, consisting of CST George Mitton, VDG Rod Wright, Simonds King Lion Calvin Currie and himself.

DG Luke asked that all PDGs present stand and be recognized. 14 PDGs were acknowledged.

The meeting also recognized one lioness in attendance.

DG Luke introduced KL Calvin, and he welcomed all lions in attendance.

DG Luke introduced Vice-District Governor Rod Wright, VDG Rod received a standing ovation, coerced as it may have been. He congratulated all the MERLOW Team members on all their hard work and reminded the meeting of the MD N Regional Leadership Institute to be held at Scotia Glen Camp 2-4 May, 2008.

CST George delivered his Roll Call Report as noted above.

The minutes of the Second Cabinet Meeting held at the Charlottetown Lions Club on 25 November, 2007, having been circulated, it was moved by Lion Terry Brown and seconded by IPDG Tim Hoban that they be approved. Motion carried.

CST George then presented the Financial Report as of 31 January, 2008. It was then moved by VDG Rod and seconded by Lion John Roberts that the Financial Statement be accepted. Motion carried.

DG Luke then called for any reports from the district's Zone Chairs.

1. Zone 2 Chair PCST Doug Cook informed the meeting of the activities of the clubs in his zone and that PDG Allison McNally was seeking interest from clubs on Prince Edward Island in the PEI Co-Ordinating Committee.

Written reports were submitted by the following:

Zone 2 PCST Doug Cook, Zone 5 PDG Fred Cook, Zone 7 Claude LeBlanc, and Zone 8 Lucio Cordisco.

DG Luke then asked for reports from committee chairs, they were as follows:

- 1. Fund-raising Chair PDG Jan Phillips reported that there is a raffle for a lions bag and stuffed lion going on today. She also reported that tickets were being sent to all clubs for a district wide raffle. These tickets are only to be sold to lions members.
- 2. Extension Chair Lion Terry Brown informed the meeting that the International Peace Poster Display will be at the convention in Moncton. It is also available to borrow from 17 29 April, 2008. Please contact Lion Terry if your club is interested.





Lion Terry also announced that there will be an Extension Workshop 9-11 October, 2008 at the Lincoln Lions Club. He also informed the meeting that he still has a few CSFII Bracelets left and that he has copies of the Proposed Awards & Criteria available.

- 3. Leadership Chair PCC Bev Semple reported on her committee's mini leadership sessions that she has been conducting. One is coming up in March and another is planned for 4 May, 2008 in East Royalty. Plans are also underway for one to be held in western PEI and another in the Miramichi.
- 4. Lion Dave Blanchard reported on the progress of the MD N Convention to be held in Charlottetown. PIP Clem Kusiak is confirmed as the guest speaker. There are three hotels available, Delta (the host hotel), Best Western and Inn on the Hill. The Meet and Greet will be held at the Confederation Centre of the Arts. He encouraged all members to attend.
- 5. IPDG Boyd Sangster reported on the Lion Ron Evans Bursary Fund for Portage Atlantic. The balance of the fund is currently \$8067.50. IPDG Boyd has sent a request to all clubs to consider donating to the fund.
- 6. PDG Association Chair IPDG Tim Hoban reported that his committee has met twice and they have been working mainly on their structure for inclusion in the Policy Manual. IPDG Tim also reported on Lions Appreciation Day on PEI and his efforts to have the same here in NB. IPDG Tim also reported on the Premier's Task Force on Non-Profit Organizations and his submission to the Minister of Finance for the upcoming budgetary consultations.
- 7. LFC Director NB PDG Fred Cook reported that LFC has approved a special skills dog for an 11 year old girl from the Burton area. It is quite rare for a person of this age to be approved for such a dog. He also reported that donations were up 112% for July December of last year compared to the same period the year before. Total donations of \$12480.00. PDG Fred also emphasized the need for clubs to get behind the Light Bulb Program.
- 8. Cavalcade NB Chair Joe Ruet reported that most everything is in place for the Cavalcade in Woodstock. Lion Joe has posters for sale to be used in fund-raising, he also has Cavalcade 2008 pins available. Lion Joe also informed the meeting that the Big Stop in Lincoln has a charity table set up for Cavalcade. He also announced the Blindfold Dinner and Concert set for Moncton High School on 6 March, 2008.

DG Luke then adjourned the meeting for lunch at 12:00 p.m.

DG Luke reconvened the meeting at 12:45 p.m.

At this time DG Luke presented Lion Keith Trask of the McAdam Lions Club with a 100% Presidents Award.

DG Luke then introduced Lion Mike Menzies to a stirring round of applause. Lion Mike spoke of the support he has received over the past year, during his illness. He specifically wanted to acknowledge the support of Zone Chair Jan Martin of District N-2 Region 10 for her help while he was in Nova Scotia receiving treatment.

DG Luke then announced that MD N pins were now available at a cost of \$3.00.

- 9. Diabetes Awareness PEI Chair Lion George Vail reported on the prospect of a new camp for diabetes in the Truro area. He also reported that the Live Smart Diabetes Expo will be held at the Rodd Charlottetown Hotel 3 May, 2008 with 34 booths. Lion George also reminded the meeting that Cavalcade PEI still did not have a chair, and that Lion Arnold Yates had offered to fill the position. DG Luke appointed Lion Arnold immediately.
- 10. Youth Exchange Chair Stewart MacDonald reported that he has prepared information for all clubs and that it is being circulated via the zone chairs. The information is a step-by-step guide to conducting a youth exchange. He encouraged all clubs to consider participating.
- 11. LFC Chair Lion Mary Small thanked all lions for their support this year and reported that her committee has raised over \$800.00 through the sale of LFC merchandise.
- 12. Lion Brian Kingston of the Moncton Lions Club reported on Convention and Officers School. All events will be taking place at the host hotel, Ramada Crystal Palace with the exception of the Meet & Greet which will be held at the Moncton Lions Club.





- 13. Elections Chair PDG Denzil Bernard reported that he has received completed applications for one Zone Chair position, for District Governor from VDG Rod, and for Vice District Governor from Zone Chair Lucio Cordisco.
- 14. Drug Awareness Chair Lion Bill Scott reported that he is working on a poster project to feature Huggy and baseball player Matt Stairs. He also announced that the Audie Brewer Memorial Bowling Tournament was scheduled for this Saturday at the Marysville Lanes. For more information contact any member of the Nashwaaksis Lions Club.
- 15. Contests Visitation & Bulletin Chair Harold Borden reported that he has only received bulletins from 5 clubs and that on ly 3 clubs have reported visitations to him. He encouraged all clubs to get this information in to him.
- 16. Alert Chair Lion Norah Davidson-Wright reported that the pilot project between the Barkers Point Lions Club and the Fredericton E.M.O. has been very successful.

Written reports were submitted and are available from the following committees:

Alert, Contests Visitation & Bulletin, LFC, Long Range Planning, PDG Association, Lion Ron Evans Bursary Fund, Awards, and Constitution and By-Laws.

PDG Jan then came forward to conduct her raffle draw. \$102.00 was realized. The winner was Lion Susan Sangster.

CST George then conducted his draw for the golf putter. \$86.00 was realized. The winner was Lion Stewart MacDonald.

#### **Old Business**

It was moved by Lion Terry Brown and seconded by PCC Sonny Bonell to accept the Awards Committee report that had been presented in Charlottetown on 25 November, 2007. Following lengthy discussion the motion was carried. Lion Terry then presented his committee's "Proposed Awards & Criteria" report as a Notice of Motion to be voted on in Moncton at the annual convention. Following lengthy discussion it was decided that this Notice shall be circulated to all Lions Clubs under separate cover and posted on the district's web site. Lion Terry will accept suggestions and comments to the report leading up to the district convention.

Long Range Planning Chair PCST Gerald Forsythe then presented his report concerning the creation of the Deputy Vice-District Governor position. The conclusion of the report was that the position not be created. It was moved by PCST Gerry and seconded by PDG Ralph Shears that the reort be accepted, motion carried.

Constitution and By-Laws Chair PCC Rheal Cormier then presented the following five (5) Notices of Motion:

- 2. Referred to as Notice #1 (Housekeeping)
- 3. Referred to as Notice #2 (Administration Fund)
- 4. Referred to as Notice #3 (Zones and Regions)

As with the Proposed Awards & Criteria Notice, these Notices of Motion shall be circulated under separate cover and posted on the district's web site for comment and suggestions. These Notices shall be voted on at the convention in Moncton. The Policy Manual will also be posted and circulated 30 days prior to the convention. It was then moved by PCC Rheal and seconded by PCST Gerry that due to the fact the above Notices replace those that were presented in Charlottetown, said Notices be recinded. Motion carried.

DG Luke then re-read IPDG Boyd's motion concerning the remaining funds from former District 41-O. The motion was seconded by VDG Rod. Motion carried. IPDG Boyd thanked all the members for supporting the motion.

DG Luke then brought forth the idea to honour the members of the Bathust High School Phantoms basketball team and the coach's wife who lost their lives recently. It was moved by PCC Sonny and seconded by VDG Rod that the district purchase a tree in the Breslau Memorial Forest at LFC to honour them. Motion carried.

Upon discussion of the upcoming MD N Regional Leadership Institute, it was moved by PDG Denzil and seconded by IPDG Tim that the district pay for ten (10) registrations, a total of \$500.00, for members of the district attending the institute. Motion carried

CST George announced that the Rexton Lions Club is hosting their 3rd Annual Ladies Night this Saturday and that any lady wanting to attend could see him for a ticket.





Lion Susan then presented PCC Sonny with a memento for his service as piper to district and multiple district events over the years.

PCST Gerry reminded the meeting of the Blindfold Dinner & Concert 6 March, 2008.

PCC thanked all members for attending.


